**JURGEN BRAUER, PH.D.**  
**EMERITUS PROFESSOR OF ECONOMICS**

Jurgen Brauer is Emeritus Professor of Economics at Augusta University's Hull College of Business and Visiting Professor of Economics, Chulalongkorn University, Bangkok, Thailand. He holds degrees from the Free University of Berlin and the University of Notre Dame (Ph.D., 1989). Widely and prominently published, he has been a Peace Fellow of the United States Institute of Peace and is co-founder and co-editor of *The Economics of Peace and Security Journal*. He has lived on five continents.

A teacher of undergraduate and graduate students, globally published columnist and public speaker, Prof. Brauer carries on wide-ranging scholarship on the economics of peace, conflict, and security.

Prof. Brauer's books include *Economic Aspects of Genocides, Other Mass Atrocities, and Their Prevention* (with Charles H. Anderton; Oxford University Press, 2016), *Peace Economics: A Macroeconomic Primer for Violence-Afflicted States* (with J. Paul Dunne; U.S. Institute of Peace Press, 2012), *War and Nature: The Environmental Consequences of War in a Globalized World* (AltaMira Press, 2009), *Castles, Battles, and Bombs: How Economics Explains Military History* (with Hubert van Tuyll; The University of Chicago Press, 2008), *Arms Trade and Economic Development* (with J. Paul Dunne; Routledge, 2004), *Arming the South* (with J. Paul Dunne; Palgrave, 2002), *The Economics of Regional Security* (with Keith Hartley; Harwood, 2000), *Economics of Conflict and Peace* (with William Gissy; Avebury, 1997), and *Economic Issues of Disarmament* (with Manas Chatterji; Macmillan and New York University Press, 1993).

Prof. Brauer's work has been published in Chinese, Dutch, French, Japanese, Korean, Portuguese, Russian, Spanish, and, in English, in an array of research journals such as the *Journal of Economic Perspectives*, the *Journal of Economic Geography*, *Economic Development and Cultural Change*, *Defence and Peace Economics*, the *European Journal of Political Economy*, *Conflict Management and Peace Science*, the *Journal of Economic Surveys*, the *Cambridge Review of International Affairs*, and *Science*. In addition, he has authored and co-authored many book chapters, among others in the *Encyclopedia of Law and Economics*, the *Wiley Handbook of Violence and Aggression*, the *Routledge Handbook of Peacebuilding*, the *Handbook of Defense Economics*, the *Handbook on the Political Economy of War*, the *Encyclopedia of Arms Control and Disarmament*, the *Oxford International Encyclopedia of Peace*, and to a Festschrift in honor of Nobel-Laureate Jan Tinbergen. Prof. Brauer serves as a reviewer for scholarly journals, book publishers, and grant-making agencies. He is a member of the editorial boards of *Defence and Peace Economics*, the *International Journal of Development and Conflict*, and *Nação e Defesa*. With Prof. Keith Hartley, he co-edits the *Studies in Defence and Peace Economics* monograph series with Routledge, London, and with Prof. J. Paul Dunne, he co-founded and co-edits *The Economics of Peace and Security Journal* ([www.epsjournal.org.uk](http://www.epsjournal.org.uk)). In 2013, he co-founded a peace economics blog and in 2014 he co-founded an international research consortium, the Small Arms Data Observatory ([www.SmallArmsData.org](http://www.SmallArmsData.org)).

Prof. Brauer has presented his work in Australia, Belgium, Canada, China, Colombia, France, Germany, Greece, Hong Kong, India, Indonesia, Italy, Japan, Israel/Palestine, Mexico, the Netherlands, New Zealand, Poland, Portugal, Russia, Spain, Sweden, Switzerland, South Africa, South Korea, Thailand, Turkey, and the U.K. He has received major funding from the United States Institute of Peace, the Ford Foundation, the MacArthur Foundation, the Winston Foundation, South Africa's National Research Foundation, the One Earth Future Foundation, the Institute for Economy and Peace, the Small Arms Survey, and Meltwater News, an internet-based news aggregator and distributor.

To his classroom teaching, Prof. Brauer brings a wide-ranging international dimension, cultural awareness, and concise and precise exposition of economic concepts. He has taught a wide range of courses, from introductory and intermediate microeconomics and macroeconomics to the history of economic thought, economic development, quantitative methods (statistics, econometrics, and forecasting), the economics of strategy, and courses and seminars in the economics of conflict, war, and peace. This interest in education is also reflected in the publication of Jurgen Brauer, Ron Friesen, and Ed Tower (compilers), *Public Economics III: Public Choice, Political Economy, Peace & War*, Vol. 20 of *Economics: Reading Lists, Course Outlines, Exams, Puzzles & Problems* (Durham, NC: Eno River Press, 1995) and teaching-related publications in peer-reviewed journals such as the *Journal of Economic Education*, *Perspectives on Economic Education Research*, and *Classroom Experiments*. His co-authored web site (with Greg Delemeester) on classroom games attracts many visitors.

He has been or presently is associated with a number of professional societies, including the American Economic Association, the American Association for the Advancement of Science, the Inter-University Seminar on Armed Forces and Society, the Peace Science Society International, and the academic honor societies of *Sigma Xi*, *Phi Kappa Phi*, and *Beta Gamma Sigma*. In spring 2015, he was inducted into the *Martin Luther King, Jr., Collegium of Scholars* at Morehouse College, Atlanta, GA, USA. He is a founding member of the Asian Peace Science Network. From 1998 to 2005, he served as vice-chair of Economists for Peace and Security. Prof. Brauer has served as speaker or consultant to the World Bank, the United Nations, NATO, the NATO Defence College, the U.S. National Defense University, the Chief Economist, Office of the Comptroller, City of New York, the Small Arms Survey, Geneva, the Institute for Economics and Peace, Sydney, the Auschwitz Institute for Peace and Reconciliation, and the Club de Madrid. For a time, he also served as Senior Research Consultant to the Council on Economic Priorities in New York City. He has held visiting fellowships or professorships at the Nelson Mandela Metropolitan University, Port Elisabeth, South Africa, the Australian Defence Force Academy, Canberra, Australia, Chulalongkorn University, Bangkok, Thailand, the Universidad del Rosario, Bogotá, Colombia, the University of Barcelona, Spain, and the University of Colorado, Boulder, where he also briefly served as Research Director for the nearby One Earth Future Foundation.

In addition to peace economics in general, his specific current research interests concern the economics and business of the firearms and ammunition industries and the economics of genocide and its prevention. He also teaches and consults on business strategy and is co-owner of two consulting companies.

A native Berliner with permanent U.S. residency, Prof. Brauer worked in the Kingdom of Swaziland for several years following his undergraduate work at the Free University of Berlin. He enjoys classical music, motorcycle touring, and various outdoor sports. A published underwater photographer, he is a certified SCUBA diving instructor and CPR and First Aid instructor.
